# 0 -4 YEARS 12 MONTHS WARRANTY USED CARAVANS - NON TRANSFERABLE

#### Leaks:

Water ingress on any permanent sealed joint being part of the Manufacturers original specification. (Excluding damage caused by user or any third party)

#### **Breaking Systems:**

All mechanical linkage, backing plates, actuators, drums and shoes.

Chassis:

All chassis members including outriggers.

Running Gear:

Axles, hubs, hub bearings, hub oil seals, road wheels (excluding Tyres and inner tubes)

Suspension:

Springs, hangers, shackle pins, bushes, shock absorbers and mouldings.

Towing Mechanism:

All mechanical components fitted as standard to caravan. (Excluding electrics)

Auxiliary Electric:

Main hook-up input connector, ELCB, battery charger and distribution unit, interior light fittings.

Cassette Toilet, (excluding, seat and seals)

Windows:

Delamination (separation) and window and roof blinds.

Cooker

Burners, grill, oven, hob, igniters, flame failure device. (Excluding glass components)

Heating System:

Thermostat, fan, switches, control unit, gas heater, flame failure device, igniters.

Water System:
